#### **HERAS PLUS Kick-off event**

On 25 November 2020, HERAS Plus Project marked the official Kick-off of the Project. The launching event took place in a hybrid format and attracted the interest and attendance of over 75 participants representing the main stakeholders, Austrian Development Agency (ADA) project holders and implementation organizations, representatives of public Higher Education Institutions (HEIs), experts and academi-

cians as well as members of the Media. The Austrian Ambassador to Kosovo, His Excellency Mr. Christoph Weidinger, addressed the Project Kick-off event and emphasized that donors are committed to support Kosovo in undertaking the necessary reforms to make the Higher Education system in Kosovo harmonized with the European standards: "a demonstration of our commitment to support the efforts of Kosovo in establishing modern, competitive, transparent, and well-functioning education

system that is line with the standards and principles of the European Union (EU)." The event was co-moderated by Ms. Diellza Kukaj, Minister's Political Advisor, and Mr. Aqim Emurli, Team Leader of HERAS Plus. The event generated a lot of interest from participants and resulted in some very insightful comments and interaction.




Figure 4. Kick-off Event, 25 November 2021

### **ACTIVITIES BY LEVELS OF INTERVENTION**

## Supporting the applied science focused instruments in Higher Education

Development of a "Roadmap for identifying opportunities for implementing Programs in Applied Sciences in Kosovo" and an "Administrative Instruction on Applied Sciences." In the framework of promoting applied sciences at the policy level to increase the relevance of study programs and graduates' labor market and employability, a roadmap was drafted to identify opportunities for the implementation of Applied Science Programs in Kosovo.

The roadmap was drafted through local

and international expertise, referring to best practices. The whole process occurred within the working group established by Ministry of Education, Science, Technology and Innovation (MESTI) and supported by the project.

Several working meetings were held leading up to the presentation and discussion of the final draft, with the participation of MESTI, representatives of the Austrian Development Agency (ADA), members of the working group, and other parties.

Building on the roadmap's recommendations, an Administrative struction on Applied Sciences was drafted using national expertise. The roadmap and the Administrative Instruction were presented to the new cabinet at MESTI, the Roadmap findings were discussed, and recommendations were given for further steps in implementing the science-based approach applied in higher education.

In addition, the project has continued to support the working group on the Higher Education Law and offered a one-day workshop on the scope of support for this activity.

## Support to Kosovo Accreditation Agency

This activity supports the Kosovo Accreditation Agency (KAA) in reviewing its current policies and practices to make them more relevant to the national context and enable more comparable, more user-friendly, and transparent assessments for all stakeholders. Some of the reached milestone activities:

#### Manual for External Evaluation of Higher Education Institutions.

The "Manual for External Evaluation of Higher Education Institutions" developed/drafted is one of the activities planned as part of the Memorandum of Understanding between HERAS Plus and the Kosovo Accreditation Agency (KAA) signed in November 2020.

The handbook provides an overview of Higher Education in Kosovo and essential developments in the Higher Education system to contextualize the meaning of the international experts engaged by the KAA for external institutional and program evaluation. The manual also explains the accreditation process and provides practical guidance to international assessment experts on implementing the Accreditation Standards Manual and related annexes for completion in the assessment process.

The manual has been approved as official training material by KAA and is used to train new Accreditation experts. The Manual package contains: (1) Main Manual (in Albanian and English); (2) Eight accompanying annexes, including relevant templates;(3) Expert input from the evaluation phase, interviews with experts, KAA, and other stakeholders regarding best practices and lessons learned, and (4) A brief report with recommendations for improving KAA processes and general quality assurance in Kosovo Higher Education. This Manual brings KAA one step closer to fulfilling the European Association for Quality Assurance in Higher Education (ENQA) requirements/ recommendations.

#### Supporting the Kosovo Accreditation Agency Law (KAA)

The support for the Law on Kosovo Accreditation Agency consisted of international expertise support for the respective working group, active participation in the working group sessions (and direct support for two sessions). The support continued after the public consultation phase, towards finalization of the law for further proceedings.

#### Review of Accreditation Standards

In December 2021, revised accreditation standards were submitted to KAA, including Institutional and Program Accreditation standards and Lists of Indicators for Institutional and Program Accreditation. HERAS Plus has engaged international and national expertise for this review and provided substantive and logistical support.

Several activities have been conducted in the framework of the activity to support the review of accreditation standards (an essential requirement of ENQAs recommendations). Three workshops were held in this activity's scope, with a broad representation of Higher Education Institutions and relevant stakeholders. The working methodology, activity plan, and roles/tasks expected from HERAS Plus and KAA were identified and agreed upon, including establishing the working group by KAA, with KAA staff and the board's representatives, HEIs, students, and other stakeholders. Inputs from working group discussions were addressed in finalizing the draft package of accredited standards, presented in the third workshop and submitted to the KAA for further procedures on December 20, 2021.

## Supporting Research and Innovation

### Drafting the Administrative Instruction on Transfer and forms of knowledge and technology transfer.

In consultation and at the request of MESTI, the project supported the development of the Administrative Instruction on Transfer and Forms of Knowledge and Technology Transfer. An input paper on Knowledge and Technology Transfer was developed

through international expertise and was presented and discussed during the working group's first meeting. Comments and suggestions from the working group and MESTI were reflected in the final version submitted to MESTI. The Administrative Instruction was finalized and processed for signature by the Minister.

#### Conference on Policy Dialogue for Research and Innovation

HERAS Plus and the Ministry of Education, Science, Technology, and Innovation (MESTI) organized the Conference on Policy Dialogue for Research and Innovation (R&I) on November 5, 2021. The event aimed to launch a political dialogue between governmental institutions and key stakeholders to develop a list of the immediate, medium, and long-term actions needed to develop an efficient and effective support system for research and innovation in Kosovo. Some of the topics discussed were R&I ethics, opportunities, barriers for researchers, Kosovo's expectations from R&I, and the role of the ac-




Figure 9. Workshop on Knowledge Transfer & Technology, 16 April 2021

ademic diaspora. The Inputs and Outcomes of the Conference informed a policy paper on the following actions identified as essential to ensure the development of a fruitful Research and Innovation system in Kosovo, which was submitted to MESTI in December 2021.

## Development of the Kosovo – Current Research Information System (CRIS)

The roadmap for developing the Kosovo "Current Research Information System (CRIS)" was developed through an extensive assessment phase through interviews, focus groups, and data analysis. The roadmap was launched, and several presentations were made at a promotional event to representatives of MESTI, Universities, and other stakeholders. In 2021, HERAS Plus signed a Memorandum of Understanding with ERASMUS +-funded project ResearchCult to avoid a seemingly overlapping activity: CRIS by enabling synergies between projects. In consultation with MESTI, HERAS Plus and the ResearchCult project, the CRIS working group was initiated and established with the mandate to: Contribute to the drafting of the CRIS Terms of References (ToR) and the drafting of the CRIS Administrative Instruction to make CRIS operational and establish the regulatory basis.

Within the working group, and with the local expertise engaged by HERAS Plus, the "Terms of Reference: CRIS Software Specifications" were drafted, the tender dossier was drafted, and the call for the selection of the CRIS developer was opened. Selection of the developer and the development and piloting of CRIS is planned to occur in the first part of 2022.

## Support to the Smart Specialization Strategy

The Smart Specialization Strategy (S3) platform was developed, tested, and launched in a dedicated event, in close cooperation with the Office for Strategic Planning of the Prime Minister's Office and the Ministry of Economic Development.

The main features of the electronic platform are an overview of the process of continuous development of S3; a database of crucial research/ development policies, reports, publications related to research and de-

velopment; communication in a mixed format of ten users from the relevant departments/units and the general public; and a basis for further advancement of features as functions (as the S3 process progresses.

## Supporting a Human-Rights based approach in Higher Education

HERAS Plus analyses and integrates into all project activities a human rights-based approach (HRBA) and has specific activities that promote human rights and gender equality. In this context, research has been conducted on good practices and existing mechanisms at the level of public universities in Kosovo to incorporate a human rights-based approach. The research has been focused on the following areas: learning environment, teaching, and research activities. The research was presented in a workshop with broad participation of relevant institutions, which contributed to discussing the report's findings and the orientation of future project interventions. Based on the discussions and suggestions of the workshop, the need arose for an analysis of gender equality in Higher Education, and HERAS Plus plans to undertake this analysis in 2022.

## Supporting the capacity building of Public Universities

Several consultative and coordination meetings were conducted with each public Higher Education Institution regarding the planned support activities, with the Baseline Assessments being the priority step in establishing the support needs. Six Baseline Assessments of the current situation in public Higher Education Institutions were drafted and launched. These Baseline Assessments covered various aspects, including the current state of institutional issues, learning and teaching environment, research and innovation outcomes and capacities, the importance of labor market programs, quality assurance, and the dimensions of a human rights-based approach. A structured process of theoretical research, data collection, meetings, and other activities were part of these assessments, e.g.,

Workshop with the University of Applied Sciences in Ferizaj on the Cooperation of the University with Industry (with the participation of staff and students). The findings of these Baseline Assessments will inform the support provided within the HERAS Plus fund dedicated to building the institutional capacities of public Universities.

A policy brief, concluding the comprehensive findings of the Baseline Assessments was presented in the Higher Education Conference by the international and national expertise, in front of representatives from the Higher Education Institutions, MESTI and other relevant stakeholders. The policy brief invited a constructive debate and feedback, which proved very relevant towards the finalization of this document.

## Supporting the strategic development of the Public Universities

The competitive/earmarked fund dedicated to the strategic development of public universities operates based on procedures and criteria included in the request for support submitted by the Universities, justifying the need for support and planned activities. Activities carried out within this fund, for each University, for 2021 are as follows:

### University "Fehmi Agani" Gjakova

In phase one, the project has supported the University "Fehmi Agani" in Gjakova (UFAGJ) in the process of developing the Strategic Plan 2021 -2025. In this context the project provided expert input and also facilitated the working group (WG) sessions. Further, in phase one, the project supported UFAGJ also in conducting successful preparation for the institutional accreditation process. The project advised the WG that was preparing the application and also conducted Mock Simulation interviews which will interact with KAA international experts during the process of institutional accreditation.

In phase two, the project supported UFAGJ in the process of reviewing and harmonization of the internal regulatory framework. In this context the project provided expert support to the WG working on this process. A package of nine documents were reviewed: (1) Regulation of procedures and disciplinary measures for students; (2) Regulation on the students' elections; (3) Regulation on internal organization and systematization of jobs;(4) Regulation on personal income of academic staff, allowances, honoraria and permanent commissions; (5) Regulation on rules and procedures for general elections'; (6) Regulation on internationalization and mobility; (7) Regulation on doctoral studies; (8) Regulation on the work of the Senate; (9) Regulation on elections at the University "Fehmi Agani" in Gjakova and the work of the University Council.

At the request of University "Femi Agani" in Gjakova, HERAS Plus has designed a comprehensive support plan dedicated to strengthen the capacity of the "Didactic Centre for Excellence in Teaching" in the following areas: Competence-based Teaching Methodologies; Management and Leadership in Education; and also Contemporary Research Methodology and Publication in Scientific Journals. Trainings for trainers were held during 2021 for: Research and Publications and Training of Management and Leadership Trainers. Further trainings will continue in 2022 mainly in the portfolio of Competence-Based Teaching Methodologies.

#### "Isa Boletini" University of Mitrovica

The University "Isa Boletini" Mitrovica (UIBM) has been supported (through engaged

expertise) with the: (a) Review and finalization of the Strategy for Scientific Research 2021-2025; (b). Drafting a plan for monitoring the implementation of the Strategic Plan and training on the use of the monitoring plan; (c). Staff capacity building through leadership training and team building.

(d). Through expertise and three-day workshop, the review and harmonization of six regulations were done: (1) Regulation on procedures and criteria for selection, re-election, and promotion of academic staff; (2) Regulation on evaluation proce-

dures related to the engagement of external collaborators; (3) Regulation on the organization and functioning of the centre for professional development and education; (4) Regulation on the operation and use of the university management system (SMU); (5) Regulation on the transfer of studies; (6) Regulation on the scope and work of the committee on statutory issues.

#### University "Ukshin Hoti" in Prizren

The project supported the University "Ukshin Hoti" in Prizren (UUHP) with expertise and related workshops in activities:

(a) Review and harmonization of the University regulatory framework. Initially, a diagnostic assessment of the legal framework (a package of 21 regulations) was conducted to analyse and understand the needs and the level of intervention (review, harmonization or drafting). A report was compiled, which served as a basis for intervention in amending the following two regulations: (1) Code of Ethics, and (2) Regulation on Disciplinary Procedure.

(b) Supporting the University working group in monitoring of implementation of Strategic Plan including providing a template and guideline. In the context of this activity, the project also assisted the University in reviewing, revising and defining the Key Performance Indicators that are part of the existing Strategic Plan.

#### University Prishtina "Hasan Prishtina"

In 2021, a Memorandum of Understanding was signed with the University of Prishtina "Hasan Prishtina" (UP) which defined the areas of support and cooperation.

More specifically, for the UP, support was provided in: (a) The "Roadmap for advising the senior management of the University of Prishtina (UP) on measuring the performance of academic staff" was developed through a comprehensive analysis of the existing legal and institutional mechanisms that exist at the UP and interviews/exchanges with crucial academic and managerial staff.

- (b) Project cycle management trainings (PCM) with individual support sessions (two training sessions and three coaching sessions for each group) for the staff of the University of Prishtina "Hasan Prishtina".
- (c) The "Regulation on Open Access to Research Infrastructure (ROARI)" was drafted to regulate the use of the Research Infrastructure at the UP and enable inter-institutional cooperation and industry and the private sector. The regulation is in the process of approval at the UP(d) Two Regulations of the University of Prishtina "Hasan Prishtina" were reviewed and harmonized: (1) Regulation for basic studies Bachelor, and (2) Regulation for Master studies. After revision/harmonization, the same were approved by the University

## University "Kadri Zeka" Gjilan

A Memorandum of Understanding was signed with the University "Kadri Zeka" in Gjilan and the areas of support for this Institution were defined. More specifically, during 2021, the following support was offered: Preparatory trainings for the institutional accreditation process including Mock Simulation sessions with all target groups that will interact with the team of KAA international accreditation experts. These groups in-

cluded the senior management of the University, staff of quality assurance, Deans (program holders), teaching staff, students, alumni (graduates) and industry/employers. Support in reviewing and revising the current Strategic Plan was provided as well.

#### University of Applied Sciences in Ferizaj (UASF)

Activities implemented with University of Applied Sciences in Ferizaj are: (a) Substantial support in the process of developing Strategic Plan 2022 – 2026 (expert input, facilitation of working groups, and workshops); and (b) Support in the process of reviewing and harmonizing the internal legal framework with the newly adopted Statue of the University.

On 17 November 2021, the project HERAS Plus launched the Baseline Assessment

## Support through the Programmatic Partnership Grants

The Program Partnership Grant scheme received six applications, five of which were selected for funding by the Selection Board. Of the awarded projects: two had as their primary focus the importance of the labor market; one had as its primary focus medical research (with social impact); one had as its central objective human rights, and one of the projects focused on the implementation of the European Standard Quality Assurance Guidelines (ESG).




Figure 29. Workshop for Programmatic Partnership Grantees, 03 November 2021




Figure 36. The first SBM, 10 February 2021
